At the commencement, BCCM Coordinator, on behalf of BCCM Oversight Committee Chair, welcomed all the participants. At the end of self-introduction, Chair of the meeting directed BCCM Coordinator to proceed to agenda-wise discussion.

Conflict of Interest: No Conflict of Interest has been reported.

DISCUSSION(S) AND DECISION(S):

Agenda Item # 1: Approval of 27th OC Meeting Minutes.

<u>BCCM Secretariat</u>: Mr. Manaj Kumar Biswas, BCCM Coordinator, BCCM Secretariat presented the decision points of 27th BCCM Oversight Committee meeting minutes with implementation status.

<u>The Chairperson</u>: The Chairperson opined that comments should be send through email (as it needs to be documented) within the timeline as BCCM Secretariat has shared draft minutes with all stakeholders including PRs with appropriate time, about ten days for this instance. She also proposed to make this period shorter.

Decision: The 28th meeting of BCCM Oversight Committee approved and confirmed the decisions of 27th Oversight Committee meeting and acknowledged the implementation status update.

The 28th meeting of BCCM Oversight Committee also approved the Performance Assessment is done by the Performance Assessment committee formed by last Oversight Committee meeting.

The 28th meeting of BCCM Oversight Committee endorsed the BCCM Performance Assessment and Secretariat Staff Performance Assessment of 2019 done by the Performance Assessment Sub Committee formed by 27th OC meeting.

The 28th meeting of BCCM Oversight Committee also decided to share the draft Meeting minutes from BCCM Secretariat within 7 days after meeting day of BCCM Oversight Committee as well as other BCCM related meetings.

Agenda Item # 2: Update on BCCM Executive Committee Meeting.

<u>BCCM Secretariat</u>: Mr. Manaj Kumar Biswas, BCCM Coordinator, BCCM Secretariat informed the meeting that BCCM Executive Committee meeting has been conducted on 26 January 2020. The meeting was Chaired by respected Secretary, HSD, MOHFW. Main objective of the meeting was to discuss The Global Fund allocation for HIV/AIDS, TB and Malaria next funding cycle 2021-2023. He informed that following decisions have been taken in the meeting:

- The meeting of BCCM Executive Committee acknowledged the fund allocation for HIV, TB and Malaria for the next grant cycle 2021-202
- The meeting of BCCM Executive Committee decided to shift USD 07 million from TB allocation to Malaria allocation for next funding cycle i.e. 2021-2023
- The meeting of BCCM Executive Committee Decided to continue current PRs for implementing the program in next funding cycle from 2021-2023 according to the PRs' performances and rating of the GF on their performances
- The meeting of BCCM Executive Committee acknowledged the funding decision of CCM Hub for BCCM Secretariat
- The meeting of BCCM Executive Committee decided to authorize and BCCM Coordinator to communicate with prospective donors and assured support for securing funds to fill up the BCCM Secretariat Funding gap prior request submission to the Health Services Division, MOHFW

Decision: The 28th meeting of BCCM Oversight Committee acknowledged the updated of BCCM Executive Committee meeting held on 26 January 2020.

Agenda Item # 3: Discussion on Funding Request development 2021-2023.

Discussions by the Constituencies:

BCCM Secretariat: Mr. Manaj Kumar Biswas, BCCM Coordinator reminded the meeting that BCCM is planning to submit The Global Fund Funding Request for 2021-2023 by 23 March 2020. The Global Fund funding request submission guideline includes BCCM Endorsement prior to submission. As, BCCM meeting is scheduled on 12 March 2020 Oversight Committee needs to review and send the final draft to BCCM for endorsement.

He also informed the meeting that respected Technical Committee Chairs have been requested to prepare presentation on funding request as suggested by Oversight Committee Chair. They have prepared accordingly.

<u>OC member(s)</u>: Prof. Dr. Mahmudur Rahman PhD, Former Director, IEDCR and Vice Chair, BCCM Oversight Committee opined that these Funding Request documents i.e. Funding Request Form, Budget, Funding Landscape, Programmatic Gap Table etc. is to be endorsed by respective Technical Committee. After approval of Technical Committee, Oversight Committee will review and send to CCM for endorsement. He queried if such endorsement was done.

<u>BCCM Secretariat</u>: Mr. Manaj Kumar Biswas informed the meeting that Malaria Technical Committee meeting is scheduled on 09 March 2020 (tomorrow). He also informed that HIV and TB Technical Committee meeting has been conducted but could not endorse as documents are not finalized yet.

<u>OC member(s)</u>: Prof. Dr. Mahmudur Rahman opined that BCCM Oversight Committee may review the funding request but should not take any decision or forward to BCCM until the committee received Technical Committee approved documents.

<u>The Chairperson</u>: The Chair of the meeting proposed to arrange another Oversight Committee meeting before BCCM meeting so that each program can arrange Technical Committee meeting and ensure process compliance.

<u>BCCM Secretariat</u>: Mr. Manaj Kumar Biswas informed the meeting that another BCCM meeting will not be possible before funding request submission deadline. If any Oversight Committee meeting needs to be arranged, it is to be done before this BCCM meeting which is scheduled on 12 March 2020.

<u>The Chairperson</u>: The Chair of the meeting proposed to arrange Oversight meeting on same day i.e. 12 March 2020 at 09:30 am and end before BCCM meeting.

<u>Decision(s)</u>: The 28th meeting of BCCM Oversight Committee acknowledged the progress of funding request development of TB, Malaria, and HIV.

The 28th meeting of BCCM Oversight Committee also decided to recommend Technical Committees of respective Diseases to submit the GF Funding Request 2021-2023 with the endorsement of respective Technical Committee by 11 March 2020.

The 28th meeting of BCCM Oversight Committee also decided to conduct another urgent Oversight Committee meeting before BCCM meeting (12 March 2020 at 09:00 am) so that all diseases program can endorse their Funding Request 2021-2023 documents by respective Technical Committee before placing to the Oversight Committee.

Agenda Item # 4: Inclusion of Malaria Expert in BCCM Oversight Committee.

Discussions by the Constituencies:

<u>BCCM Secretariat</u>: Mr. Manaj Kumar Biswas, BCCM Coordinator informed the meeting that due to the death of one Oversight Committee members (discussed under agenda item 02 of 27th

meeting), one position of Malaria Expert became vacant. Oversight Committee needs to select new member for the position which was included under agenda item 07 of 27th Oversight Committee meeting. The meeting decided to collect CV of prospective member and place in this meeting for review and selection. BCCM Secretariat communicated several OC members for reference as prospective member. But could manage only Once CV (Professor (Dr) Md. Ridwanur Rahman) who is malaria expert and member of malaria Technical Committee. The CV is included in the meeting file. Oversight Committee members may review and decide.

<u>The Chairperson</u>: Chair of the Oversight Committee requested members to review the CV and comments accordingly.

<u>CCM member(s)</u>: Prof. Md. Abul Faiz, Former Director General, DGHS and Vice Chair, BCCM informed the meeting that he proposed the name in last meeting who is working on malaria for long.

<u>OC member(s)</u>: Prof. Dr. Mahmudur Rahman, Former Director, IEDCR and Vice Chair, BCCM Oversight committee opined that we can include proposed person as he is working and contributing for long on malaria.

<u>The Chairperson</u>: Chair of the Oversight Committee proposed to include Professor (Dr) Md. Ridwanur Rahman in BCCM Oversight Committee as Malaria Expert.

<u>Decision(s)</u>: The 28th meeting of BCCM Oversight Committee decided to include Professor (Dr) Md. Ridwanur Rahman in BCCM Oversight Committee as Malaria Expert member.
